

# Terms and Conditions

## **CAG Devon Expansion project prize draw, managed by Resource Futures on behalf of Devon County Council.**

### **1 How to enter**

To participate in this prize draw you must complete the Community Action Group (CAG) network survey and provide your name, daytime phone number (including area code) or email address.

### **2 Entry**

No purchase is necessary. Entries can only be made by completing the survey distributed by Resource Futures on behalf of Devon County Council. Each community group may make only one entry. The closing date for entries is 5pm on Tuesday 11 April 2023.

### **3 Eligibility**

Entry to the prize draw is open to community groups working on environmental issues within the administrative area of Devon County Council. The entrant completing the survey must be over the age of 18 and be part of a Devon based local community group. Members and Directors of Resource Futures, and all staff directly involved with this project at Devon County Council are not eligible to enter.

### **4 The prize**

One prize of £50 prize money for your community group will be awarded, payable to the winning group as a bank transfer

### **5 Prize winner selection**

The winner will be selected from all valid entries using a random number generator. The draw will take place within the first seven days following the survey completion date of 11 April by Resource Futures in conjunction with Devon County Council. Decisions made by Resource Futures and Devon County Council relating to this prize draw will be final and binding. By entering the prize draw, entrants agree to be bound by these rules and the decisions of the judges, which will be final and binding in all matters relating to the prize draw.

### **6 Notification**

The winner will be notified by email (or by telephone if they have no access to email and a telephone number is provided). If any winner cannot be contacted, or in the event of non-compliance with these prize draw rules and requirements, the prize will be forfeited and an alternate winner will be selected. If no acknowledgement of award acceptance is received within 14 days a new winner will be drawn. Upon prize forfeiture, no compensation will be given.
